Manufacturing businesses are particularly vulnerable to the risks posed by cybersecurity threats. The National Cybersecurity Society (NCSS), a national nonprofit organization, was established to educate businesses on IT security best practices and advise them on the type of products and services they need to protect themselves. Mary Ellen Seale, CEO and Founder of the NCSS, who is a leader in national cybersecurity strategy and cyber operations having served over 30 years in Federal service, will provide an overview of the cybersecurity risks that threaten your business. Ms. Seale will outline the likelihood of these events occurring; the impact such events could have on your operations, and actionable steps you can take to protect your business.

Mary Ellen Seale is a leader in national cybersecurity strategy and cyber operations – and has held several executive level positions with the federal government. She retired with nearly 31 years of federal service, and continues her public service by contributing to the cybersecurity needs of the business community. Previously she was Deputy Director, Cybersecurity Coordination, Department Homeland Security, (DHS), Executive Director of Modernization, Federal Communications Commission, Deputy Director, National Cybersecurity Center/DHS, and Chief of Administrative Operations, DHS Headquarters. Ms. Seale received an undergraduate degree for the University of Georgia and master of business administration (finance) from the American University and is a Certified Information Systems Security Professional.
